RELEASE OF LIABILITY

VISITLETHBRIDGE.COM ODYSSEY 2021 CHALLENGE

Please Read Carefully

Release of Liability and Waiver of Claims

In consideration of being permitted to participate in the VisitLethbridge.com Odyssey 2021 Challenge (“Odyssey Challenge”) and all related activities, including any activities incidental to such participation (“Participant Activities”), I the undersigned Participant releases VisitLethbridge.com, the Lethbridge Lodging Association and its Partners, Partnership Hotels, officers, directors, employees, sub-contractors, sponsors, agents, assigns, and affiliates of both the Lethbridge Lodging Association and its Partnership Hotels* (hereinafter collectively referred to as “LLA”) from any and all liability, claims, demands, actions or rights of action for any illness, injury, death, or damage to myself and to my property, which are related to or are in any way connected with my participation in the activities, scheduled or unscheduled, arranged by LLA. This within Release specifically includes but is not limited to the negligent acts or omissions of the LLA. I agree that the foregoing obligations shall be binding on me personally, as well as upon my heirs, assigns, and any and all members of my family including any minors accompanying me, if any.

Further, on behalf of myself, my heirs and assigns I promise and covenant not to sue, assert or otherwise maintain any claim against LLA for any injury, death, or damage to myself or to my property arising from or in any way connected with my participation in any activity arranged by LLA.

I further agree to indemnify and hold harmless the LLA from and against any and all losses, claims, suits, actions, damages or liabilities (including without limitation, legal fees and disbursement on a solicitor and its own client basis) assessed against them as a result of or in connection with my actions during, and in connection with, the participating in the activities with respect to the Odyssey Challenge.

Assumption of Risk

I acknowledge and I am aware that participation in the Odyssey Challenge contains certain risks, including but not limited to, illness, injury, death, or damage to myself and to my property. I acknowledge and I am aware that these risks may arise from the nature of the Odyssey Challenge itself, the negligence of others, conditions of the highways and roads utilized by the Participant, the use and operation of a motor vehicle, the use and operation of other motor vehicle drivers, conditions of the various competition locations, the conditions of the premises, and activities on the premises at various competition locations, the adequacy of the Participant’s motor vehicle, the condition of my motor vehicle or the condition of the motor vehicle used by me in participating in

the challenge, my cellular phone, cellular connection, battery life, weather, site conditions, my own physical condition, first aid and emergency treatment and/or lack thereof, consumption of food and drink. I am voluntarily participating in the Odyssey Challenge with the full knowledge of the risks involved and I agree to accept all of risks of participation and agree to abide by the rules as updated and outlined on the VisitLethbridge.com website (“LLA Website”). I accept and acknowledge that any failure on my part to not abide by the rules will result in disqualification from the event (promotion) and I acknowledge that I have read and understand the rules and regulations of the Odyssey Challenge.

I understand that the LLA reserves the right to make photographs, film records, recordings, or any other record of any of the Odyssey Challenge, and hereby agree that the LLA may use such photographic or film records or any other record of my participating in the said Odyssey Challenge, without remuneration for any purpose including, without limitation, commercial use, commercial use of the VisitLethbridge.com website or any of its affiliates or Partnerships Hotels Website, or for any promotional and/or commercial purposes of any nature in the sole, absolute and unfettered discretion of the LLA. I also further consent to my name to name, age, sex and race result being published on the LLA Website.

Entirety of Agreement & Severability

I understand that this Agreement is the entire, integrated agreement between myself and the LLA, and that it can only be modified or changed in writing signed by both parties. I expressly agree that the releases contained in this Agreement are intended to be as broad and inclusive as the laws of the Province of Alberta allow, and that if any portion hereof is later found to be invalid or not enforceable, the balance of this Agreement and the herein releases shall continue in full legal force and effect.

Acknowledgment of Effect of Release

IN SIGNING THIS DOCUMENT, I FULLY RECOGNIZE THAT IF ANYONE IS HURT OR INJURED, OR PROPERTY IS DAMAGED WHILE I AM ENGAGED IN THE LLA ODYSSEY CHALLENGE, I WILL HAVE NO RIGHT TO MAKE ANY CLAIM OR FILE A LAWSUIT AGAINST THE LLA OR RELEASEES EVEN IF THE LLA OR RELEASEES NEGLIGENTLY CAUSES BODILY INJURY OR PROPERTY DAMAGE.
